- **Annual Budget 2021/22**

Councillors are required to set a budget <sup>1</sup> outlining its spending in various categories for the forthcoming financial year.

As a general advice to the council, it would be that provided the council has worked out a budget for the forthcoming year, (allowing for ongoing commitments, inflation, and new projects) it would be reasonable to set a precept that it is needed to fulfil those requirements. In doing so, regards should be given to the level of balances of the unallocated reserves that could contribute towards project costs, if that was an appropriate consideration. Each expenditure heading should be considered in isolation, necessary and proportionate.

County Councillor informed the council that this location the road is in a poor and unsafe condition for speeds of 60mph. Until major road repairs have been undertaken by Welsh Government, the safe speed is 40mph.

Normally repeaters are placed in accordance with the guidance from the Traffic Signs Manual, which the table below is likely to be from. However technically the legal document, the Traffic Signs Regulations and General Directions 2016 does not require repeaters so technically the limit would be enforceable. The debate would be whether a court considers the lack of repeaters sufficient excuse so as a driver would not be able know what the limit was. They may quash a fine if they considered not following the guidance of TSM raises sufficient doubt.

I have copied Jo the Area Engineer to advise on the signing of the limit here.

*We are unable to change now without going through the whole process again which we as an authority are unable to. We looked at the plan of the area and chose the most appropriate locations for the extents and I am sure the Community Council were happy with that.*

*We have to be careful when setting speed limits and where they are should match a change in the road environment so that drivers can understand why the limit is there and then hopefully respect that limit. If we push the limit out further people may not make the connection of the change with the environment and then it's impact where you need it is lost to some extent.*
