PD/00089/21 Hendy Wind Farm

The following applications to discharge conditions by Hendy Wind Farm Ltd, were discussed by the community council.

Discharge of Condition 9 (Micrositing) 18/0981/DIS

As part of the original planning application for this development the applicant must provide permissive routes to allow equestrian users to access a route over 200m from each turbine, and as such the applicant must ensure that these routes are constructed appropriately.

Council requests that the condition not be discharged until:

- 1. Powys County Council are satisfied that the developer has checked the definitive line of the public rights of way on their land to ensure that they understand where they are located,
- 2. And if any PROW needs relocating, permission has been obtained from PCC Countryside Services to make the necessary changes.

Discharge of Condition 14 (Substation) 20/2110/DIS

Council reiterates the comments that were submitted with the objection on 12 February 2021.

Discharge of Condition 23 (Surface Water Management) 18/0984/DIS

Council requests that the condition not be discharged until:

- 1. Powys County Council are satisfied that the developer has checked the definitive line of the public rights of way on their land to ensure that they understand where they are located,
- 2. And permission has been obtained from PCC Countryside Services for the installation of the drainage channels that cross PROWs,
- 3. And Powys County Council are satisfied that no surface water from the development is directed towards any PROW, or discharges into drainage associated with the PROW.

Discharge of Condition 28 (Traffic Management) 20/2112/DIS

Council requests that the condition not be discharged until:

- 1. Welsh Government Highways are satisfied that the developer has provided sufficient information for the use of the A483 trunk road,
- 2. And that any changes needed to the trunk road (e.g. development of new emergency laybys) are completed.

Council further requests that no delivery of AILs should be permitted until condition 28 is discharged.

NMA for Removal of Condition 31 (Highway Works) 21/0091/NMA

Council objects to this application, in regard to the statement in the covering letter that "no works are required to the [northern] entrance", due to the fact that this entrance is substandard in relation to at least the following:

- Visibility (see PCC Highways response to planning application 21/0905/REM, which includes visibility calculations performed by Highways for this entrance)
- There is insufficient distance between the A44 and the common gate for HGVs to stop and open the gate HGVs either have to stop on the highway, or pull onto the track with part of the vehicle still overhanging the highway
- The track across the common is a single lane with no passing places close to the A44

Discharge of Condition 38 (Protected Species Protection) 18/1015/DIS

Council requests that the starling and bat surveys be published on the Powys County Council Web site, or made available to the council.

Council further requests that no further turbines be erected until the starling and bat surveys have been made available to the council, and the council has had time to comment on them.

Discharge of Condition 40 (Habitat Management and Enhancement) 18/1008/DIS

Council requests that the condition not be discharged until the concerns raised by NRW and Ecology have been addressed.

Council further requests that no further turbines be erected until the condition is discharged.

Discharge of Condition 41 (Ecological Monitoring) 18/1009/DIS Council has no comments.

Changes to some of our pricing and services

We're making changes to our business accounts, including price changes to some of our services. Some of these changes will only affect customers with certain products or that use particular services, so we've separated these out and summarised them below.

These changes are fully explained in the Notice of Variation booklet. You can read and download the booklet on our website at: **business.hsbc.uk/charitablesupport**.

The booklet and other relevant product information are available now and will remain unchanged while the information is still relevant. The changes are effective from 1 November 2021, unless specified otherwise.

Why are we doing this?

If you accept these changes, you don't need to do anything and they'll be applied automatically. We'll also apply these changes to any additional secondary account(s) you open in the future, unless we advise you differently.

What happens if you don't accept the changes?

If you don't accept the changes which relate to specific accounts, services or products, you must tell us before they come into effect; you'd then have to close your account(s) without charge[†]. You'd still have to

Changes to accounts you hold as at 31 May 2021:

- Priority Payments The £6.00 charge for receiving High Value and Priority Payments was previously removed because of an issue with our billing system. We've now fixed this issue, so the charge will be reinstated from 1 November 2021. Don't worry, we won't be recovering any previously unbilled charges for this.
- SEPA Credit Transfer We've identified that we haven't been applying the item charge of £0.20 for payments received to accounts by SEPA Credit Transfer. We've now fixed this issue, so the charge will be reinstated from 1 November 2021. Don't worry, we won't be recovering any previously unbilled charges for this.
- **Complaint referrals** We're updating the complaints section of our Business Banking Terms and Conditions to include details of the Business Banking Resolution Service.

Changes to our Community Accounts

From **1 November 2021**, our Community Accounts will no longer be available, as we're introducing a new **Charitable Bank Account** for charities and not-for-profit organisations that operate for a charitable purpose.

What does it mean for you?

We'll change all of your current account(s) to Charitable Bank Account(s) from the date above. The new account will carry a monthly fee, and cash and cheque transactions will now be chargeable. However, automated transactions will continue to be free e.g. Direct Debits, Internet Bill Payments, Debit Card transactions etc.

Full details of the charges are found in the Notice of Variation booklet.

We understand introducing charges isn't a welcome change, but the cost of processing manual transactions (like cash and cheques) has continued to rise, especially where overall volumes are falling, so we need to make sure we can continue to meet the needs of our customers in a sustainable way.

What changes will you see?

- The Charitable Bank Account has a monthly account fee of £5.00
- Cash paid into and out of your account over the counter will be charged at 0.40% of the value deposited or withdrawn
- Cheques paid into and out of your account over the counter will be charged £0.40 per cheque
- Change supplied over the counter will be charged 1.5% of the full amount
- Auditors Certificates will charged at £25.00 plus VAT
