Dear Powys Council Planning Department,

I write to you in relation to the resubmitted/current planning application reference PP-12479693 for the proposed construction of a combined heat and power plant (CHP) at The Ffaldau Waste Re-cycling Centre, Llandegley, Llandrindod Wells, LD1 5UD.

Following concerns from both Powys Councils ecologist Emma Guy and by NRW regarding ammonia emissions from the exhaust outlet on our proposed CHP installation and consultation with Mr Luke Jones Powys Councils Planning Officer we decided to withdraw our original application ref. Powys 22/1631/FUL to seek ways to address ammonia levels and mitigate for them.

After investigating a number of options to mitigate the emission levels, we have sourced an ammonia scrubber unit that can be attached to the CHP units exhaust systems filtration, this captures and removes in excess of 99% of ammonia from our systems output. The company is a German manufacturer called Tholander who not only supply ammonia scrubbing technology but guarantee their scrubber units performance. (see attached letter confirmation)

Tholander have provided a solution that will reduce our CHP unit's ammonia to such a low level it cannot be detected in the flue gas, in excess of 99% will be removed in this process, effectively giving us practically Zero output.


We are convinced that this mitigation measure will satisfy previous concerns and we are hopeful that our planning application can now proceed especially as this was the only obstruction to achieving permission.

In addition to capturing the ammonia sulphate particles we have taken the further mitigation measure of seeking collection and final disposal of the ammonia using a fully gualified and permitted company situated in Cardiff.


Deliver / collection by Tradebe Gwent WMC Permit EPR/SP3531SK for bulking up prior to disposal (D15) then Transfer to Castle Environmental, Cardiff Permit EPR/LP3439HM Physico-Chemical treatment - Neutralise sulphuric then raise pH to drive off ammonia, re-capture in scrubber and then recovery.

We would like to thank you for giving us the opportunity to source the mitigation technology enabling the opportunity to continue with our proposed project.



## Proposed CHP plant










At the start of the meeting a presentation was made by Mr Justin Horrell, Digital Project Manager, One Voice Wales about his role and the project. This was followed by a number of questions about the project.

#### AGENDA

1. Welcome by the Chair

Cllr Clive Easton welcomed everyone to the meeting.

2. Apologies

There were no apologies.

3. Declarations of interest

None declared.

4. To approve the draft minutes of the meeting held on 14<sup>th</sup> June 2023

The minutes were approved subject to a minor change regarding the two schools referred to.



- 5. Actions and matters arising from the above minutes (not otherwise on the agenda) or previous meetings
  - a. Wind Farms the Freedom of Information request discussed at the last meeting

It was resolved that the FOI request should be sent to Welsh Government as previously discussed.

#### ACTION: CE and GJ to discuss the final wording of the letter.

b. Powys Health Board Stakeholder's Group

AH said that he had again written to Powys Health Board following on from the last meeting but had received no response. Following discussion it was resolved that this matter be left at his stage as it was no longer considered to be a priority (see also 10 below).

c. The Passif Housing Development at Clyro

AH said that he had spoken to a project officer at Powys County Council about this and there was no information or data available in order to assess the impact of the various energy initiatives that are part of the development.

d. Radnorshire Wildlife Trust

The information provided by the CEO James Hitchcock after his presentation at a previous meeting of the Area Committee had been circulated at the time. There is no further information to add at this time.

- 6. News and reports of good practice from Councils
  - a) Builth Wells TC MH reported on the development of a Friendship Agreement project between Builth Wells TC and Blaubeuren in Germany.
  - b) Llanwrthwl CC AA said that considerable progress had been made with the project to protect and enhance the rights of way in the area and that this was being supported by very enthusiastic volunteers.

# ACTION: AA to prepare a presentation to the Area Committee at the next meeting.

c) Rhayader TC – AA referred to the youth club initiative that had been successfully introduced by the town council.

ACTION: Rhayader TC to be approached for further information about a presentation to the Area Committee at a future meeting.

- 7. Reports from bodies on which the Area Committee is represented:
  - a. The National Executive Committee (NEC) of One Voice Wales: Cllr Mark Hammond (meeting 15<sup>th</sup> September)

MH provided a brief report about the meeting and AH will circulate the minutes of the NEC meeting with the draft minutes of this evening's meeting.

b. Powys Public Services Board

AH said that he had circulated information to members received from a named contact at Powys PSB last week. An event for town and community councils in Powys is to take place in the coming months and further information will be circulated when received.

8. The Wales Air Ambulance Service at Welshpool – Cllr Mark Hammond.

MH provided an update to members. He stated that it was vitally important that town and community councils across Powys should now respond directly to the consultation that closes on 5<sup>th</sup> November. It appears that the project is being driven by the need to reduce costs and the likely favoured option is to relocate the current Air Ambulance Station away from Welshpool and merge existing services at Ruthin.

# ACTION: CE & MH to formulate an appropriate letter to be sent on behalf of the AC as part of the consultation process.

9. Town and Community Council multi-location meeting arrangements, including the recent survery of arrangements amongst councils in Brecon & Radnor.

CE said that it was important that all town and community councils undertake their business in accordance with the legal requirements and that the auditors address these matters as part of their work of auditing local councils. Any shortfall should be identified and addressed accordingly, otherwise there was no point in having these requirements in place.

AH provided a summary of the survey he had undertaken to try to establish a more accurate picture of how councils were operating hybrid meetings in Brecon & Radnor. This involved appoaching those councils directly or scrutinising their websites to gather the required information:

Of the 63 town and community councils in the area (58 are in membership of OVW):

- 27 clearly provide the necessary facilities;
- 1 is imminently in the process of doing so;
- 12 are able to provide such facilties if requested by councillors or members of the public;
- 15 clearly do not provide such facilties (mainly due to connectivity issues and lack of broadband);



• 8 councils did not respond to messages left for them or their website does not provide sufficient information.

AH said that he had shared the above information with the Regeneration Department (Brodband Project) at Powys CC and they are very keen to support all town and community councils across the county in meeting the requirements to provide hybrid council meetings. The had already worked closely and provided considerable funding to many councils already and they want to hear from others. Their contact details are: Broadband@powys.gov.uk – Clifford Shapland and Mike Lewis.

 Suggested priorities for the Brecon and Radnor Area Committee for the 2023/24 period

CE said that he wanted the Area Committe to be serving a positive and useful purpose on behalf of town and community councils in the Brecon and Radnor area and to represent those councils effectively. He added that there appeared to be a lack of participation and willingness to get involved in the work of the Area Committee and attendance levels seem to have dwindled during the last couple of years. With this in mind CE had asked councils for some suggested priorities for the Area Committee for the next 12 months. Three councils had returned suggested priorities and these were circulated before the meeting.

Following discussion it was agreed that the following be adopted as the priorities of the work of this Area Committee for the next 12 months:

- a) To continue to try to improve working relationships between town and community councils in the Brecon & Radnor area and Powys County Council;
- b) To represent the views of town and community councils about the various wind farm projects and also the likely construction of hundreds of electricity pylons in the local area;
- c) To share good practice being undertaken by town and community councils across Brecon & Radnorshire;
- d) To present the views of town and community councils to the ongoing review of the Welsh Air Ambulance base at Welshpool;
- e) To continue to work closely with the Wye and Usk Foundation.

The chair said that it was important that examples of good practice be shared with town and community councils and that any local success stories of partnership working with Powys County Council, Bannau Brycheiniog National Park Authority, and any other organisation should be highlighted and communicated to other councils, particularly the contact details of individuals who have provided valuable assistance in addressing local matters and helping to solve problems within council areas.

ACTION: Member councils to provide examples of good practice of working with other public authorities and local organisations, incuding Powys County Council and the Bannau Brycheiniog National Park Authority to AH.



11. The Democratic Health of Town & Community Councils Project – suggestions for increased participation by local people in the work of local councils

Following discussion it was resolved that member councils should consider this matter further. CE mentioned councillor mentoring schemes.

ACTION: Member Councils to forward any ideas directly to AH and to bring suggestions back to the next meeting of the AC in January.

NOTE: Member councils should note that a circulation regarding a survey was recently sent to all OVW member councils and the consultation closes on 27th November 2023.

People in attendance at meetings are not allowed to make any recording of a meeting unless they have received the prior consent of the Council (in practice this would be via a resolution at that meeting). The relevant legislation that applies in Wales (but not in England) is the Public Bodies (Admission to Meetings) Act 1960. The public do not have a statutory right to use any means which would allow persons not present at the meeting to see or hear the proceedings of

a meeting. Councils are therefore entitled to permit or refuse the taking of photographs or the use of video cameras or audio recording devices (including, for example, a mobile phone) at meetings (s.1(7) of the 1960 Act). In practice of course it will be very difficult for councils to police this requirement, especially when people are 'attending' online.



Hi Geraint,

Thanks for responding, yes certainly:

In 2022 Wales Air Ambulance attended 264 missions in Powys, 204 were by helicopter and 60 by rapid response vehicle on the ground. 21 of the missions occurred during the night shift (between 7pm and 7am).

Also I think it's useful to emphasise that we respond to the most critically ill and injured, bringing A&E to the patient. It's much more advanced than it used to be (when the crew used to essentially transfer the patient to A&E as quickly as possible), it's now more about sending the most appropriate team of medical staff to the incident for pre-hospital care.
