'Councillors are required to set a budget outlining its spending in various categories for the forthcoming financial year. As a general advice to the council, it would be that provided the council has worked out a budget for the forthcoming year, (allowing for ongoing commitments, inflation, and new projects) it would be reasonable to set a precept that it is needed to fulfil those requirements. In doing so, regards should be given to the level of balances of the unallocated reserves that could contribute towards project costs, if that was an appropriate consideration. Each expenditure heading should be considered in isolation, necessary and proportionate.

Proposed, That Powys County Council be informed that the precept for Penybont & Llandegley Community Council be set as £9454. **Proposed** Cllr D.Turner Unanimous
